- **YourCourts Updates:**
 - ◆ Change Court 1 to one-hour sessions in the afternoon (12-7). Leave other courts with the current times (one-hour 9-12, 90 minutes 12-7:30). Passed, and to be implemented.
 - ◆ Add a drop-in group once a month, two weeks after the Dink & Drink. Current D&D is the 2nd Friday, so this would be the 4th week of the month.
 - ◇ Provide analysis on the least used late afternoon time slots M-T-W for the last two months for the board to review
 - ◇ There is no involvement with the Social Committee, this is wholly Steve's responsibility
 - ◇ Ask Steve which works best for him
 - ◇ Paddles in fences should be used, not a white board which is 'confusing'
 - ◆ Report back to the board for final decision
 - ◆ Move one group play sessions to 11AM for each group, so it's not so hot:
 - ◇ Provide analysis on how courts are being utilized during the last two months, showing the number of open time slots for morning hours
 - ◇ See if the Novice group leaders are available for a morning session

- ◇ Propose days/times and number of sessions for review by the board for final decision
- ◆ Allow players to have 5 prime time slots during morning sessions: Provide analysis of how many open slots there are in the mornings, report back to the board for final decision
- ◆ Allow professional trainer:
 - ◇ Provide analysis of how many slots are available during the afternoon hours (12-6) for last two months
 - ◇ Ask Gil if willing to reduce packages from 10 to 5
 - ◇ Ask Gil how many people he wants to train per week
 - ◇ Report back to the board for final decision
- **Court Management Update:** Reported all is fixed with exception of cobwebs from lights. Continued communication with maintenance. Posted sign on ball machine storage shed is missing. Umbrellas must be put down after use.
- **Tournament Director / Social Director Update:** Guys/Gals Tournament was enjoyed by all participants. An unavoidable concern was mentioned, players games were either to close or far apart.
Dink & Drink will be Friday, July 12, 2024.
- **Publicity:** Articles of pickleball events continue in The Villager
- **Old Business:** Update of Bylaws for an additional position on the board – Approved
- **New Business:** Rossmoor sent message requesting a tournament in the fall. They cannot provide courts at their facility, want to come here. Declined by unanimous vote.
Approved cost of 20 pails for new game, Pickleball Pong to be played in golf cart parking area during events.
